- Exchange information about organisation, working methods, etc.
- Discussing cross border health care issues

- General presentations on the position, organisation and tasks of their supervising systems
- Specific presentations
  - Assuring quality of care in times of market oriented health system reforms
  - Medical practice and disciplinary measures in the European Union
  - Free trafic of health care professionals
  - Inspection program for blood(products)
  - Certification and supervision in health care

## Third EPSO Meeting, 1999

- Risk assessment
- Supervision of quality and professional and institutional standards
- The need for cooperation between supervisory organisations
- Methods of audit
- Grading of deviations, reactions at different levels
- Open sessions



## Fourth EPSO Meeting

- 24nd 25th October 2002, Gardermoen, Norway
- Discussion about a Declaration of Intent
- EPSO should represent central supervisory agencies that have similar problems
- EPSO should be an arena for the discussion of common issues and problems
- Only problems experienced by participating organisations should be addressed
- EPSO should focus on how to get better at what organisations do, rather than how they could do things differently



#### Topics to discuss

- Risky health professionals
- Education of supervising personnel
- Overview of organisations involved in supervision and their responsibilities
- Development of supervision methodology
- Relationship between control and advising
- Root cause analysis of incidents
- Developing a web-site for EPSO
- Quality indicators
- Financial effectiveness of health care institutions
- Accreditation/certification of health care institutions



#### EU Chair The Netherlands Conference Amsterdam, December 2004

- Addressing the problems of health care personnel crossing borders
- All EU and EFTA countries were present (departments of health and supervisory bodies)
- Declaration of Amsterdam
- UK took over the topic and organised a meeting in Edinbrough in October 2005
- Result: a certificate of good professional standing
