





 Act on authorization of health care and on professional health care practice






# Highlights

- Acute limiting of the license, in case of danger for patient safety
- Regulation of cosmetic treatment and registration of all doctors performing cosmetic treatments
- Limited license at the at the age of 75





#### Surveillance and Supervision







#### Target areas

- Identification and management of the professional misconduct
- Identify risk areas





#### Focus

- Prevention
  - Guidelines
  - Professional regulations
- Organization
  - Recommendations of change
- Risk personnel
  - Pursuit of persons with repeated deficient professional performance





#### Supervision of health personnel

- Personal inability to practice (fitness to practice)
- Deficient professional performance





#### Personal fitness to practice

- Illness
- Abuse




- Mandatory treatment and control








#### "Risk personnel" - Intensified Surveillance

## Nursery homes - background

- Since 2002
- One yearly inspection by the local offices
- Process of heightening the quality and equality of the inspections





## Nursery homes – new standards for supervision

- 71 standards
- Health administrative issues
  - instructions
- Health issues
  - medical records
  - specialist visits
  - handling of medication
- Health related issues
  - hygiene
  - mobilization







#### Cosmetic treatment 1. December 2007

- Treatments that represents a risk for the patients, can be regulated by the NBH
- The use of equipment that represents a risk for the patients, can be regulated by the NBH
- All authorized health personnel and their assistants have to be registered at the NBH since 1. April
- So far 129 applications and 102 registered

# Medical substitution treatment of persons with opioid dependence

- Buprenorphine as first choice
- The general rules for substitution treatment
  - other health parameters
- Treatment with injectable methadone (06)
- Treatment with injectable heroin (09)





#### Increased surveillance of benzodiazepines

- Focus on the use since 2005
- Revised rules 2006
- Increased surveillance by the local NBH

Act on Patient Safety in Danish Health Care System (now The Health Act)

- The Act came into force on 1st of January 2004
- Includes the secondary sector
- Soon to be extended to include the primary sector as well
- Local responsibility NBH responsibility





#### Characterization of the reporting system

- Mandatory
- Confidentiality
- Sanction-free
- Learning-orientated

## Examples on follow-up

- Alerts
  - electrical sheets, anesthetic equipment, suffocating in soft fixation belts
- Reports
  - Suicide, medication
- Recommendations
  - preparation before surgery, follow-up on test results
- Binding Guidelines
  - Medication, avoiding wrong-side surgery (the five steps)
